# OUR SPEAKER: MAURIEL P. JOSLYN

A native Georgian, Mauriel P. Joslyn received her B.A. in History from Mary Washington College in Fredericksburg, Virginia, and her M.A. in History from Georgia College and State University.

A librarian, teacher, re-enactor, screenwriter and author, Joslyn won an award for Georgia Author of the Year in 1996, for best biography.

Her books include Valor and Lace: Roles of Confederate Women; Charlotte's Boys: Correspondence of the Branch Family of Savannah, Georgia 1862-1865, A Meteor Shining Brightly: Essays on Maj. Gen. Patrick R. Cleburne, Immortal Captives: The Story of 600 Confederate Officers and the U.S. Policy of Retaliation, and Biographical Roster of the Immor-

*tal 600.* She has also written numerous articles for various history magazines.

Joslyn is currently working on a book based on interviews with 36 World War I British Royal Flying Corps personnel.

# OUR TOPIC: "THE IMMORTAL 600"

The Immortal 600 is the story of 600 Confederate officers held, for retaliation, on Morris Island and at Fort Pulaski over the winter of 1864-65. The story follows Union and Confederate efforts and experiments with placement of prisoners in the last year of the war, and the politics of President Abraham Lincoln, Lt. Gen. Ulysses S. Grant, and those of lower rank in the prisoner-of-war saga. The 600 suffered hardships

#### that were, even then, against the laws of the First Geneva Convention, and their story gives detailed insight into how men cope with captivity and starvation.

## HCWRT PAST PRESIDENT RECEIVES DUFOUR AWARD

Harry Bounds passed along the information that Jim Mundie, past president of HCWRT, has been chosen to receive the Civil War Round Table's annual Charles L Dufour Award of Merit.

Mundie was selected because of his books, *The Confederate Generals Buried in Louisiana* and co-authorship of *Texas Burial Sites of Civil War Notables* (he is currently working on a second volume of the Texas burial sites). His book on the Louisiana CSA generals prompted similar efforts in other states, helping preserve the graves of many of written about in the books. The books have also brought recognition to many soldiers who might otherwise have been forgotten.

Mundie will accept the award at the New Orleans RT's meeting on April 20. We congratulate him heartily on receiving both the award and recognition of his determined efforts to preserve local history sites.

# CW CONFERENCE IN CONROE APRIL 30

# FORMER RT PRESIDENT DIES

Dr. Artie Quintus Cato, a former RT president (he was also treasurer and vice president) died early in February this year. Born in Austin, Dr. Cato graduated from the University of Texas and worked as a chemical engineer for nine years before deciding to pursue a career as an orthodontist.

Services were held Feb 12, and Dr. Cato was buried in Forest Park Lawndale Cemetery.

Dr. Cato was active in the RT long before my time, so I don't remember him. I regret that we had lost contact with him, especially as we celebrated our 50th anniversary last year.

# FALL FIELD TRIP: RED RIVER

The Red River Campaign will be HCWRT's Fall Field destination this year. The dates are October 27-31 (Thursday - Monday). The inestimable Ed Bearss will be our tour guide again this year.

We'll fly into Alexandria, Louisiana, on Thursday, Oct. 27. On Friday, we'll tour Old River, Fort DeRussy, Simmesport and the battles of Mansura, Yellow Bayou and Dunn's Bayou.

Saturday, we'll tour the battles of Henderson Hall, Monett's Ferry and Blair's Landing. We will also pick up important sites at Bailey's Dam, Natchitoches, Grand Ecore, Finerille, Fort Buhlow and Fort Randolph. On our last touring day, we'll visit the battlefields of Pleasant Hill and Mansfield. We'll fly back into Houston on Monday, Oct. 31.

We don't have approximate costs for the trip yet, but Tony thinks it will be comparable to the last couple of years. Lunches will be included, and possibly, a dinner or two. A \$250 deposit must be made to confirm your reservation; another deposit will be due during the summer (we'll give you exact dates), and the final deposit must be in Tony's hands by the September RT meeting (Sep. 15).

### WOMEN AND THE CIVIL WAR CONFERENCE

The 7th annual Conference on Women and the Civil War is scheduled for June 3-5, at Virginia Tech University in Blacksburg, VA. Varied topics, all related to women and the Civil War, will be discussed in workshops and lectures.

Workshop sessions are scheduled on Friday, June 3, beginning at 12:30. A welcome reception that evening, from 5:30-7:00 pm, will feature remarks by Dr. James (Bud) Robertson, Jr.

Lectures begin at 8:45 on Saturday, and continue until 5:15, with time out for lunch. A dinner and after-dinner program will begin at 7:00 pm Saturday evening.

On Sunday, a special tour of Smithfield Plantation, the 1774 home of Col. William Preston from noon until 3:00, followed by a visit to the nearby Preston family cemetery for approximately one hour.

#### **PRESERVATION NEWS** by Joyce Kennerly

**Parker's Crossroads, TN** The Parker's Crossroad Battlefield Association (PCBA) recently purchased nine acres of core Parker's Crossroads battlefield land (about halfway between Nashville and Memphis).

It was a group effort: monies came from The Civil War Preservation Trust, the Tennessee Lands Acquisition, the Tennessee Wars commission and the American Battlefield Protection Program Civil War Battlefield Preservation Program (a matching grant).

The land purchased is adjacent to I-40, and includes the burial site of several Union soldiers. Although most were exhumed and moved to Corinth after the war, a few were found only recently.

This purchase brings the total number of acres saved at Parker's Crossroads to 180. The PCBA is trying to save an additional 100 acres of core battlefield.

The Battle of Parker's Crossroads, fought in December 1862, involved troops under Gen. N.B. Forrest and Union Brig. Gen. Jeremiah Sullivan, who was trying to keep Forrest from crossing the Tennessee River. Forrest's troops found themselves surrounded, and when they reported that to the general, he gave one of his most famous commands, "Charge them both ways." They followed his orders and fought their way out.

Steve McDaniel, a member of the Tennessee House of Representatives, was the first president of the PCBA. He and the organization received the HCWRT Vandiver Award of Merit in 1995 for their grassroots efforts to save this battle ground, mostly forgotten until McDaniel and PCBA went to work. We're proud to see how their continued efforts are paying off.

The organization has developed a driving tour, carries out a biennial reenactment, and is continuing to develop tour markers and trails. It also hopes to replace the current small welcome center with a larger interpretation center.

Its most ambitious goal is to buy 52 acres along the north side of I-40, the site of many Confederate artillery positions. At present, much of the battlefield land is still open fields, but development along the freeway is bringing increased pressure for private development of those lands. PCBA hopes to get as much as it can before it's too late.

#### Franklin, TN

Franklin city officials have approved \$2.5M in matching funds to purchase 110 acres now occupied by the Country Club of Franklin. The land, which makes up the eastern flank of the battlefield, is one of the last large tracts of pristine battlefield land still available at Franklin. It is owned by a descendant of the McGavock family, who owned Carnton Plantation, which is adjacent to the country-club property. Heller has offered the property to preservationists for \$5M, if it can be raised by June 2005.

Franklin's Charge, a coalition of preservation groups, has begun fundraising efforts to match the city's vote for \$2.5M in funds. By presstime, I was not able to find a contact for donation information, but I will keep looking and report next time where you can send your donation toward the matching funds.
