#### COMMANDER'S CORNER By Mike Harrington

This is not an easy message for me to deliver to the membership of the Houston Civil War Round Table. For sure, it was not an easy message to write.

I don't have to tell you that the past five or so months have been difficult ones for our Round Table, our city, our state, our nation – indeed, for virtually the entire world. In addition to the troubles that the Coronavirus has visited on us, America has witnessed rolling waves of indiscriminate urban violence. The mob mentality that first contented itself with toppling Confederate statues soon spread to the desecration or outright destruction of memorials honoring everybody from Christopher Columbus to a Spanish priest in old California, to George Washington and Thomas Jefferson. Not even General Grant's statue in San Francisco or the Boston memorial to the black Union regiment, the 54th Massachusetts Infantry lauded in the movie *Glory*, has been spared the mob's blind wrath.

Joining in this "cancel" culture movement, some city governments – including Houston's – have removed Confederate monuments from display. More recently, Democrats in the Texas Legislature have demanded the removal of all Confederate monuments on the capitol grounds, including those honoring Terry's Texas Rangers and Hood's Texas Brigade.

At a time when so much unthinking public emotion has been directed towards Civil War figures, the Houston Civil War Round Table, I am proud to proclaim, will persist with its historic mission: namely, the *nonpartisan* study and discussion of, in the words of our charter, "the history, battles, personalities, and significant events of the War Between the States."

As you will read elsewhere in this newsletter, our Board of Directors has reluctantly decided to hold our monthly meetings by Zoom until such time as we are comfortable that in-person meetings can be resumed without significant risks to the health of our members, guests or speakers. Our Board is continuing to evaluate several potential new venues for our monthly meetings, with the aim that we will have a fitting place to gather when it's safe to recommence in-person meetings.

In closing, let me end on a high note. I am excited about our speaker line up for the new campaign; I hope you feel likewise, notwithstanding our temporary movement to virtual meetings. Thanks in large part to the tireless exertions of our prior programs chair, Gary Chandler, over the nine months beginning in September we will hear from a variety of accomplished speakers covering a wide range of topics related to the Civil War. Of particular note, the recipient of our latest Vandiver Award, **Dr. Brian Steel Wills**, will be with us in November, either virtually or in the flesh. The full line up of our scheduled speakers and their respective topics are presented on the last page of this newsletter.



# THE NEW TEMPORARILY VIRTUAL HCWRT

As President Mike Harrington indicates in his column, the pandemic is greatly impacting our ability to have in-person meetings for at least the beginning of the 2020-21 campaign. We do not want to expose our members or speakers to this virus, nor would we expect much attendance if we were to hold an in-person meeting. Due to the fact that the H.E.S.S. Club has permanently closed, the Board of Directors is exploring several options for a new venue. However, we are having difficulty getting a new venue to commit to us until the situation returns closer to normal. Our intent is to return to in-person meetings as soon as we are able to do so.

In the meantime, we want to continue to meet as best as possible and have decided to conduct our meetings virtually by Zoom starting in September.
